A fully completed entry form is to be submitted to the Auctioneers office on or before 13:30pm on the Friday immediately prior to the auction sale.

ANY ITEM NOT ACCOMPANIED BY A COMPLETED ENTRY FORM WILL NOT BE SUBMITTED FOR SALE

All items are sold under the Livestock Auctioneers Association (LAA) conditions of sale. Copies of which are displayed throughout the mart.

All items remain the sole property of the Vendor until such time that the item is sold or is disposed of by the mart. C&D Auction Marts Ltd or their representatives accept no responsibility whatsoever regarding items left on their premises.

The vendor acknowledges that they have full right of title to the items submitted for sale. Where the vendor does not have full right of title, then a confirmation letter from the title holder is to be provided prior to the sale confirming the eligibility of the items to be sold.

No vehicle will be offered for sale without being accompanied by a valid V5 registration certificate.

DELIVERY OF SALE ITEMS

Items will only be accepted onto the mart site between the hours of 09:00am and 13:30pm on the Friday immediately prior to the auction sale.

NO items will be accepted outside of these hours, without prior arrangement.

NO items will be accepted for sale on the day of sale.

UNSOLD LOTS

All unsold items are to be removed from the mart site within 14 days of the sale at which they were offered for sale. Items remaining on site after 14 days will be disposed of as scrap.

VENDOR COMMISSION

Implements and other items are charged at the rates displayed in the mart office

Small Tools – VENDOR commission of 15% plus VAT per item (minimum of £2.00 plus VAT)

PURCHASER COMMISSION

All items purchased will be subject to a purchaser commission of 5% plus VAT (Maximum of £150.00 plus VAT per item purchased), based on the NET (ex VAT) amount. Purchaser commission will be added to items at the time of invoicing.

All items are to be paid for on the day of purchase by either Cash or Card.

All purchased items are to be removed from the mart site within 14 days of the sale at which they were purchased. Items remaining on site after 14 days will be disposed of as scrap.

DESCRIPTION, WARRANTIES AND GUARANTEES

Any item described as being in working order or running order or good condition, shall have no defect which renders it incapable of the reasonable work for which it is intended and must be capable of performing such work.

Any item described as being in good working or good running order shall be mechanically sound and capable of performing the work for which it is intended. No item shall be returnable for any description, warranty or guarantee other than that affecting its working, running, or mechanical condition.

No description other than year of make, maker's name, and type will be given unless warranted in working or running condition.

The Auctioneers accept no responsibility for damage due to frost.

SELF BILLING AGREEMENT

The seller (self-billee) agrees to accept invoices raised by C&D Auction Mart Limited for a period of 12 months from this agreement. The seller agrees not to raise sales invoices for the transactions covered by this agreement and to notify C&D Auction Marts Limited if the seller changes their VAT number, ceases to be VAT registered, or sells their business or part of it. C&D Auction Marts Limited confirms as buyer they will issue self billed invoices for all supplies made in the period, and that the self billed invoices will show the relevant information to constitute a VAT invoice.
